OHS Addresses Child Safety Through Webinar

In June, OHS hosted a webinar entitled, "Addressing Child Incidents Through a Culture of Safety." This extremely informative webinar highlighted several critical specifics related to the Office of the Inspector General (OIG) report that was released in 2022. Some particular highlights are as follows.

Types of Incidents

52% of the incidents that the OIG found were related to supervision. A child left more than three minutes unsupervised is the benchmark to be used when reporting these incidents. Other incidents were related to "child abuse", which could be things such as inappropriate discipline, emotional or verbal abuse, and physical child abuse. The remainder of the incidents were related to unauthorized releases, where a child is released to a person not on record.

Reporting

There were multiple questions and conversations regarding reporting on this webinar. The first person to call is your program specialist or your regional program manager. You should not wait to hear back from the state to determine if it is a substantiated incident. Although OHS would like to see this reporting done without delay, there is up to seven days to report it. It cannot be later than seven days, but ideally as quickly as possible so that all can be supported throughout. After seven days, monitoring findings will be issued to the program.

What to Report?

Any incident that results in serious harm or injury to the child must be reported. Incidents that violate the Head Start Standards of Conduct, such as humiliating children, emotionally abusing children, or using Inappropriate discipline are examples. Physical punishment is also included as well. Incidents where children or left alone, unsupervised, or released to an unauthorized adult also need to be reported.

Understanding Child Incidents and Reducing Them

Lack of training can be a factor in child incidents. Training around Active Supervision is critical. Professional Development, so staff know how to keep children safe is integral, as well as educating staff about developmentally appropriate behaviors and challenging behavior. Second, staff wellness is found to be directly connected to child safety and adult wellness has to be supported by programs. Creating a strong "emotional climate" where staff feel like they are cared for matters. Third, programs need to understand and acknowledge that adults come to this work with their own personal beliefs. Training and professional development need to understand these philosophical and cultural differences.

ILookout, found on ECLKC as part of their iPD, is an online training from Penn State designed to be Head Start specific and OHS is working to make this an training that can meet the mandated reported requirement.

New Worlds Reading Initiative

The New World's Reading Initiative has been expanded to include eligible VPK students. These students, scoring below grade level on the FAST STAR Early Literacy Assessment PM1 are eligible to receive free books on a monthly basis until the student exits fifth grade. Parent and teacher resources are also included. Books are distributed no later than October and continue until at least June.

<u>Emergent Literacy Micro-Credential</u> <u>Available to all Early Learning</u> Educators

All staff are eligible to participate in the Emergent Literacy Micro-Credential. Upon completion of the three components, the participant earns a \$2,000 stipend. Participants will be asked to complete an application and will be paid by Business Services through the UF Lastinger Center and the learner is paid directly. This microcredential is job embedded, meaning the work can be done within the context of the classroom experience and it supports the language and literacy requirements of the CDA professional portfolio as well.
